As we look forward to spring, the LaSalle SWCD would like to extend you an invitation to be a field host in a springtime self-guided Cover Crop and Conservation Practices tour. We are dividing the County into five regions- Northwest, Northeast, Southwest, Southeast, and the panhandle with 6-8 sites being within each region to view. There are so many great cover crop and conservation practices out there to showcase to fellow farmers that are interested in learning more about them. A self-guided, driving tour is a way that would be helpful to get more folks seeing and talking about conservation and cover crops. We are looking for covers and conservation practices that can be seen from the road.

Cover Crops are starting to gain more momentum within the County, and this is a great way to show other curious farmers what you are doing and how it looks in the process. The information that we are looking at collecting is what type, seeding rates, termination, etc. While driving past fields, folks can see the growth of the cover, how it works in different landscapes, what different types of covers look like, how they are terminated, grazed, etc. This information would be provided to those who take the tour so they can see what things look like at different rates, species, etc.

Conservation Practices are a huge part of the farming operation in some cases. They are great for reducing soil erosion, improving water quality, providing wildlife habitat, increasing soil biology, and the list goes on.
